

LICENCE INFORMATION

HOW TO APPLY: Fill out all the details on the ANT Annual Registration Form. Enclose a copy of your current insurance certificate and a copy of your current BSS pass certificate if not already held by us together with your payment. Post in the self addressed envelope or to the office address on the front of this leaflet. **Cheques payable to 'ANT'.**

ALL CRAFT moored on, or using for any purpose whatsoever, or for whatever period any part of the Avon, including that part upstream from its confluence with the Severn, all marinas, basins and back waters must display a current licence. Private licences do not cover boats that are hired out, used for commercial gain or reward, or are in time share ownership. Please contact the office.

THE ANNUAL licence covers the River Avon from Alveston Weir to the confluence with the Severn at Tewkesbury and runs from 1st January to 31st December and is not transferrable from one craft to another. No refunds are given for boats sold, the licence remains with the craft.

BOAT SAFETY SCHEME: If not already held by ANT, a copy of a current BSS certificate must be provided. The Boat Safety Office (01923 201278) will provide details of exemptions.

THIRD PARTY INSURANCE: All craft (powered and unpowered) must be insured. ANT recommends at least £2m cover including salvage cover. Copy of current certificate must accompany all annual registration forms.

PROMPT JANUARY APPLICATIONS, are only available by post to take advantage of the Prompt January price and must enclose **ALL** required documentation.

PROMPT FEBRUARY APPLICATIONS, can be purchased by post or from one of our agents but needs to be bought before the end of February or you will be liable for the **FULL** fee.

AFTER 1ST SEPTEMBER, annual licences applied for on or after this date 50% discount.

ELECTRIC OR STEAM powered craft, 50% discount.

RESIDENTIAL BOATS (as per bye-law 30a). Any boat occupied for residential purposes for an aggregate period of more than 6 weeks in any one year must apply annually in writing for permission with their licence application form, and if granted, will be subject to an annual extra charge of £100 on top of the annual licence fee. A residential licence will then be issued. These applications are only available by post.

CONCESSIONARY LICENCE may be applied for by riparian owners' unpowered craft under 15ft, rescue craft and workboats. Proof of insurance will be required.

RECEIPT. The counterfoil receipt found at the bottom of the registration form will be issued if the lock keeper/agent cannot issue the licence due to insufficient documentation. The receipt should be clearly displayed on the craft until the licence is issued.

NON REGISTRATION. If necessary, the Trust will prosecute boat owners who fail to pay their licence fees and they will be subject to debt recovery action through the courts. In addition, boat owners who make no attempt to register or to satisfy the BSS and insurance requirements are liable to prosecution.

BW RECIPROCAL LICENCES. The Trust has reciprocal licensing arrangements with British Waterways. Boaters with an annual ANT licence and a permanent mooring on the Avon can purchase a discounted reciprocal, 3,6,9, or 12 month BW licence at 20% discount for canals & rivers or rivers only. Boaters with an annual BW licence and a permanent mooring on BW waters can purchase a discounted reciprocal annual ANT licence at 20% discount as shown in the table of charges.

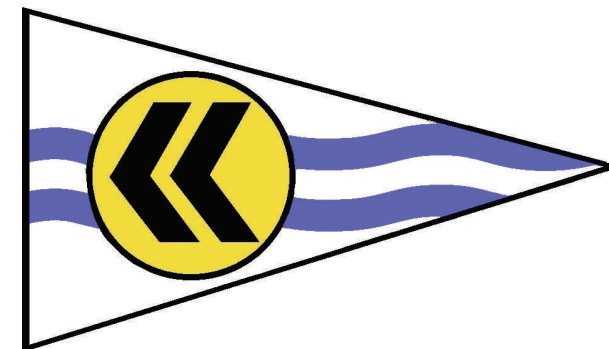
