

## LICENCE INFORMATION

**HOW TO APPLY:** Fill out all the details on the ANT Annual Registration Form. Enclose a copy of your current insurance certificate and a copy of your current BSS pass certificate, if not already held by us. Post in the self addressed envelope or to the office address on the front of this leaflet.

### PAYMENT OPTIONS:

**Cheque:** Made payable to 'ANT' with application.

**On-Line Banking:** Sort Code 20 98 61 Account 63227529 use boat name as reference. **Send application in advance** and date the form same as payment date.

**Card Payment:** Please provide phone number on application form and we will contact you to make payment.

**ALL CRAFT** moored on, or using for any purpose whatsoever, or for whatever period any part of the Avon, including that part upstream from its confluence with the Severn, all marinas, basins and back waters must display a current licence. Private licences do not cover boats that are hired out, used for commercial gain or reward. Please contact the office.

**THE ANNUAL** licence covers the River Avon from Alveston Weir to the confluence with the Severn at Tewkesbury and runs from 1<sup>st</sup> January to 31<sup>st</sup> December and is not transferrable from one craft to another. **No refunds are given for boats sold**, the annual licence remains with the craft. All craft **MUST** have a permanent mooring.

**BOAT SAFETY SCHEME:** If not already held by ANT, a copy of a current BSS certificate must be provided. The Boat Safety Office will provide details of exemptions.

**THIRD PARTY INSURANCE:** All craft (powered and unpowered) must be insured. ANT recommends at least £3m cover including salvage cover. Copy of current certificate must accompany all annual registration forms.

**PROMPT JANUARY DISCOUNTS**, are only available by post. To take advantage of the Prompt January discounted price **ALL REQUIRED DOCUMENTATION AND PAYMENT** must be enclosed otherwise the **FULL FEE** will apply.

**PROMPT DISCOUNT APPLICATIONS**, can be purchased by post or from one of our agents and must be purchased before the end of February if your boat is afloat and **ALL REQUIRED DOCUMENTATION AND PAYMENT** must be enclosed otherwise the **FULL FEE** will apply.

**AFTER 1ST AUGUST** - Annual licences for boats that arrive or are launched on or after this date can apply for a 50% discount of the prompt fee. **PROOF OF LAUNCH DATE OR ARRIVAL DATE REQUIRED, ALL DOCUMENTATION & PAYMENT REQUIRED.**

**ELECTRIC OR STEAM** powered craft, 40% discount.

**CRT CONTINUOUS CRUISING CRAFT:** can only apply for a short term licence.

**RESIDENTIAL BOATS** (as per bye-law 30b): Any boat occupied for residential purposes for an aggregate period of more than 6 weeks in any one year must apply annually for permission with their licence application form, and will be subject to an annual extra charge on top of the annual private licence fee. A residential licence will then be issued. These applications are only available by post. The boat **MUST** have a permanent mooring.

**RECEIPT:** The counterfoil receipt found at the bottom of the registration form will be issued if the lock keeper/agent cannot issue the licence due to insufficient documentation. NO licence will be issued until documents are received.

**NON REGISTRATION:** If necessary, the Trust will take legal action against boat owners who fail to pay their licence fees and they will be subject to debt recovery action through the courts. In addition, boat owners who make no attempt to register or to satisfy the BSS and insurance requirements are liable to legal action.

**TENDER:** A Private licence covers one tender which must be, unpowered, 15' long or less, in the same ownership, identified as 'Tender to (parent vessels name)' and can be carried either on davits or on the parent vessel.

**CRT RECIPROCAL LICENCES.** The Trust has reciprocal licensing arrangements with Canal & River Trust. A boat owner with an annual ANT licence and a permanent mooring on the Avon can purchase a discounted reciprocal, 3,6,9, or 12 month CRT long term licence at 20% discount for canals & rivers or rivers only. A boat owner with an annual CRT licence and a permanent mooring on CRT waters can purchase a discounted reciprocal annual ANT licence at 20% discount as shown in the table of charges. Proof of permanent mooring and CRT licence will be required.

**CONCESSIONARY LICENCE** may be applied for by rescue craft and non-commercial workboats. Proof of insurance & BSS certificate will be required

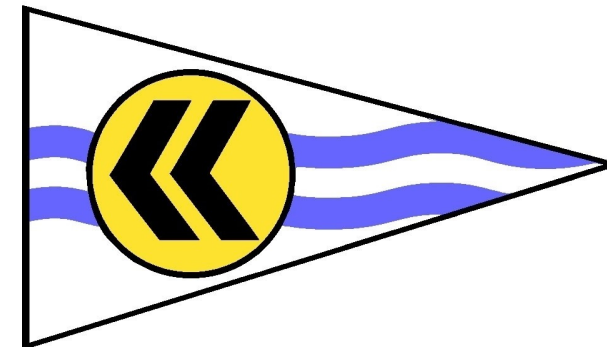
